Fee Development Partnership Program

The Process

1. A thorough review of each opportunity is conducted and a formal offer for development capital is provided.
2. The developer prepares a project budget and site plan, and submits them to the tenant for approval.
3. VEREIT or one of the Cole REITs enters into a long-term net lease with the tenant.
4. At land closing, all costs are capitalized at an agreed-upon cap rate, and monthly draws are funded during construction.
5. The completed project is retained by VEREIT or one of the Cole REITs.
